## MEMBERSHIP CONTRACT

### Membership Information

Dues for the Colorado FrontRangers are \$20 per year for individuals or \$30 for a household. Annual dues pay for newsletter production, mailing costs, other club expenses and some club activities. Most Colorado FrontRanger events are designed to pay for themselves, so fees for individual activities are common. The club's fiscal and membership year runs from October 1 through September 30. See table below for prorating of dues. All memberships expire on September 30 and are up for renewal at that time.

A household membership consists of the primary member and a secondary member. The first name listed on the FrontRanger Membership Contract is the primary member, who will receive a copy of the club newsletter. If the household is dissolved, the primary member shall remain a member of the club. The secondary member will need to obtain his own full membership to remain in the club and receive his own copy of the newsletter.
